*Note b: Regardless of category of application, all applicants will be reviewed for an Early Offer if they have completed the equivalent of ten full courses towards a degree by September 1, 2018 and have written the LSAT by September 8, 2018. The Early Offer score for 2018-19 admission was 75.119.

Winter Term 2019 grades and will not be considered for the 2019-20 admission cycle.

For all categories of admission, web-based transcripts are acceptable for assessment purposes. **An official transcript is not required until an offer is made, and accepted.**
