SELECT YOUR COURSES

It will be your responsibility to make sure that you are registered for all your mandatory courses which are listed below. This means that you will have 15 credits hours for your second year, you must now select a further 15 credits. Second Year students may register beginning August 1 at 11:00 am.

In each of second and third year, you are required to take at least **ONE** Research and Writing Component. A Research and Writing Component involves at least one paper worth at least 60% of the grade, comprising a minimum of 7,500 words (excluding footnotes and bibliography). Prepare alternate choices that work in your timetable if you are unable to get your first choice when you are registering in Aurora. You may also take more than one perspective course.

You must also choose several elective courses. Please bear in mind the following factors as you are choosing your electives and additional perspectives:

- You may participate for credit in **one moot competition** in each of **second and third** years, but no more than one per year, and you may not participate in the same moot twice.
- The Research Paper is available in both terms and you may select the term in which you will take the credit. The application form must be completed and submitted to Rosa Muller.
- Moots, Research Paper and the Publications courses are not available for to registration on Aurora self-service because those courses require approval of the Associate Dean's office.
- You cannot receive credit towards your J.D. for any courses taken anywhere during May to August without prior approval of the Associate Dean.
- You may elect to take one 3-credit *non-law university course*. You **must first get permission** from the Associate Dean and then submit a letter indicating (i) the name, number, faculty and department of the course, (ii) an outline of the course, (iii) a statement that there is no scheduling conflict with any of your law courses, (iv) whether the course is part of the completion of a degree other than you J.D., and (v) a statement of how the course fits with your pre-law studies, law courses or career plans.

The following are the courses from which you may choose your electives. Because some have limited enrollment, please select enough courses to bring your total credits to at least 30, and then rank several alternative courses that fit your schedule in case you cannot register in your first choices.
