

Special Guest Bios



Professor Emeritus Cameron Harvey – 55 years teaching law

Professor Emeritus Cameron Harvey started teaching at the University of Manitoba's Faculty of Law in 1966 and continues teaching to this day.

He obtained a Bachelor of Arts degree from the University of Toronto in 1961, an LL.B. in 1964 from Osgoode Hall and an LL.M. from the same in 1966.

Since joining the Faculty at the University of Manitoba, he has led an active academic career, being involved in many Law Faculty Council committees, particularly Admissions. He served a number of years as the University of Manitoba Conciliator, and 15 years as Associate Dean, working closely with Deans Roland Penner, Art Braid and Harvey Selter. He retired in 2006, but continues teaching part time in the subject areas of Agency and Partnership, and Private International Law.

In addition to years of involvement in the Law Society Bar Admission Course and various commissions, including 30 years chairing Manitoba's expropriation compensation tribunal, he has also been President of the Manitoba Law Reform Commission since 2006.

Outside of the Faculty of Law, he taught law-related courses to laypersons through the UM's Continuing Education Division, City Planning, Natural Resources Institute, and the Faculty of Management.

He has published much legal literature including eight books, 10 casebooks for internal use by students of the Faculty of Law and the Bar Admission Course of the Law Society of Manitoba, 20 reports or briefs for government departments and agencies, over 50 articles and comments and 27 book reviews in various law journals, a few newspaper articles, and more than 240 reasons for judgment of the Manitoba Land Value Appraisal Commission, more than 130 of which are published in the Land Compensation Reports.



Exploring a Human Rights Research Legacy: A conversation with Professor Karen Busby

In this, the 40th anniversary of her graduation from Robson Hall, Professor Karen Busby engages with former student and now colleague, David Ireland in a conversation about her life devoted to legal research and teaching in the field of Human Rights and as the first director of the Centre for Human Rights Research. This will be Professor Busby's last year teaching at Robson Hall.

After first studying Economics and Political Studies, Professor Busby completed her law degree at the University of Manitoba in 1981. She was called to the Manitoba Bar in 1982 and practiced for a year with Thompson, Dorfman, Sweatman. After studying in France for a year, she was the first clerk with the Federal Court of Appeal (1984-87), before completing an LL.M. at Columbia University in 1988.

She joined the Faculty of Law at the University of Manitoba in 1988, and was the Founding Director of the University of Manitoba's Centre for Human Rights Research in 2010. Among her many awards are the Dr. and Mrs. H.H. Saunderson Award for Excellence in Teaching (2015), and the Canadian Bar Association "Hero" Award (2006).

Professor Busby's most recent funded research has focused on the right of First Nations Communities to clean water, Sex Work Laws in India and Canada, investigations and policy development regarding rape culture at universities, criminal sexual assault attritions analysis and surrogate experiences.

For decades, her name has been well-recognized by practicing lawyers across Manitoba as the editor of the Manitoba Queen's Bench Rules Annotated. Her most recent book was *Achieving Fairness: A Guide to Campus Sexual Violence Complaints* co-authored with Joanna Birenbaum, published by Carswell in 2020. Since its publication, she and Birenbaum have been delivering workshops on various aspects of campus sexual violence policies.

Professor Busby has a long history of involvement in national equality-seeking organizations including the Women's Legal Education and Action Fund (LEAF) and Egale Canada. She has also served on the boards of various visual arts organizations including the Winnipeg Art Gallery, and regularly comments in the media. She was on the federal Advisory Committee on the Framework to Prevent and Address GBV [Gender Based Violence] at Post-Secondary Institutions (2018 - 2020), and she was a member of the Complaints Process Community Practice with Courage to Act.



Dean of Law, Dr. Richard Jochelson

Dr. Richard Jochelson was appointed Dean of Law at the Faculty of Law, University of Manitoba July 1, 2021. He holds a Ph.D. in Law from Osgoode Hall Law School at York University, a Master of Laws from the University of Toronto Faculty of Law, a Bachelor of Laws degree from the University of Calgary Faculty of Law (Gold Medal), and a Bachelor of Science in Zoology (with Distinction), also from the University of Calgary. He served his articling year as a clerk at the Alberta Court of Appeal and Court of Queen's Bench, before working at one of Canada's largest law firms. He taught criminal law for 10 years at the University of Winnipeg prior to joining the University of Manitoba's Faculty of Law in 2016.

During his time at Robson Hall, he has further developed a student-centered pedagogy which is responsive to student needs, and which permits the course to be formatted to students' talents. As a researcher, Dr. Jochelson has disseminated over 70 publications, many of which deal with police powers and jurisprudential approaches to police powers and the socio-legal placement of the laws of obscenity and indecency. He has also published more than 15 co-authored books and edited works.

Dr. Jochelson is the recipient as both Principal Investigator (PI) and Co-investigator (CI), of Social Sciences and Humanities Research Council (SSHRC) Insight Grants in teams of four to six people. Further, he has assembled nearly 40 cross-Canada interdisciplinary scholars to help the research network that has become Robsoncrim.com (a leading research blog). Together, this collective of legal scholars has helped make the Criminal Law Edition of the *Manitoba Law Journal* one of Canada's preeminent criminal law journals.



Host, alumnus and professor, David Ireland

David Ireland was called to the Manitoba Bar in 2011, and is currently a professor specializing in the area of criminal law and procedure, evidence law and advocacy at the University of Manitoba's Faculty of Law. A graduate of Robson Hall with both a J.D. and LL.M., his legal practice included both defence and prosecution work. He has also been involved in public interest legal work concerning inquests, public inquiries and human rights. In 2016 he joined the Faculty of Law, and his research program centres on improving the delivery of criminal justice in Canada.



Michael Badejo, MLSA President

Currently serving as President of the Manitoba Law Students Association, Michael was last year's Manitoba Bar Association student representative. Committed to giving back to the community, he was presented with the MBA President's Award of Excellence in 2021 for helping 1L students connect with mentors, and advocating for student needs at the national level. Michael comes to the Faculty of Law from a career in media relations and corporate communications. He holds a joint degree/diploma in Communications from the University of Winnipeg and Red River College.
