## From the Dean's Desk

#### Updates of new initiatives



As Dean of the Faculty of Law, I am delighted to present to you this year's edition of our Alumni Magazine on behalf of our academic faculty, practicing professionals, and administrative staff. Our community of alumni exemplifies the practical and critical values instilled by a law school education in Manitoba. Your remarkable achievements continue to make us immensely proud, and we cherish your association with the University of Manitoba's Faculty of Law.

At the Faculty of Law, we have a strong commitment to providing our students with practical and experiential opportunities that prepare them for success in their legal careers. We understand the importance of bridging the gap between education and practice, which is why we continuously expand our clinical and Continuing Professional Development (CPD) offerings.

I am pleased to update you on some of the initiatives we have undertaken over the past year:

- 1. JD/MBA Joint Degree: Starting in Fall 2024, we will be offering a joint law and business degree program that combines the Juris Doctor (JD) and Master of Business Administration (MBA) degrees. This exciting opportunity allows students in Manitoba to pursue this valuable joint experience without having to leave their home province.
- 2. Master of Laws Streams of Study: Under the guidance of Associate Dean (Research & Graduate Studies) Donn Short, the LLM now offers streams of study: Human Rights; Business; Indigenous Studies; Law and Society; Criminal Law; Public Policy; and Practice. For the first time, working in our pro bono clinics can count as coursework towards an LLM! Expect more exciting announcements this year regarding our graduate program.
- 3. Expanded Clinical Offerings: Under Director of Clinics and Experiential Learning, Liz McCandless [LLB/2007, LLM/2020] we have broadened our clinical courses to offer significantly more experiential learning opportunities to third-year law students. Over two-thirds of the students in their final year have applied for externship opportunities this year, choosing from an expanded range of options. Our Rights Clinic continues to operate, and we now offer externships at esteemed organizations including the University of Manitoba Community Law Centre (UMCLC), Manitoba Law Reform Commission (MLRC), Legal Help Centre of Winnipeg (LHC), L. Kerry Vickar Business Law Clinic, Public Interest Law Centre (PILC), plus exciting new externships at the Indigenous Community Legal Clinic, Manitoba Department of Justice, , Women's Legal Education and Action Fund (LEAF), and Law Library Hub.
- 4. Expanded Desautels Centre for Private Enterprise and the Law Offerings: Under the guidance of Professor Darcy MacPherson and Dr. Laura Reimer, the centre continues running advanced education experiences and produces a blog, case reporter and annual journal. The refreshed centre is on track to make even more major announcements this year. Stay tuned!

- 5. Expanded Master of Human Rights
  - **Experiences:** With Dr. Nathan Derejko as our inaugural Mauro Chair for Human Rights and Social Justice, we are anticipating significant growth in our human rights curriculum including improved clinical experiences.
- 6. Expanded Concentrations in the JD Program: In addition to our existing Access to Justice in French concentration running under Director Dr. Lorna Turnbull, we have introduced three new concentrations to provide students with specialized knowledge. These include Private Enterprise and the Law, Criminal Law, and Law and Society.
- 7. Indigenized Curriculum: Thanks to the dedicated efforts of Marc Kruse [JD/2015], Director of Indigenous Legal Learning and Services, the Truth and Reconciliation Action Team, and many others, we have enhanced our curriculum to align with Call to Action #28. Our improved curriculum ensures that our law students receive education on Residential Schools, Indigenous culture, and history. We are fortunate to have the guidance and wisdom of two esteemed Elders-in Residence, The Honourable Murray Sinclair [LLB/1979], and our long-serving Instructor and retired Student Advisor, Wendy Whitecloud.
- 8. **Clerkships:** We also provide valuable handson for-credit opportunities to third-year law students through clerkships with the Provincial Court, Manitoba Court of Queen's Bench, and the Manitoba Court of Appeal.
- 9. Career Services Enhanced and Expanded: Our career and professional development services team of comprised of Director of Professional Development Trina McFadyen [LLB/2000] and Lisa Griffin, Career Development Coordinator, have continued to expand their impressive suite of services, placing over 90% of students with articling opportunities and preparing them life beyond Robson Hall. Trina McFadyen is also the Faculty of Law's EDI liaison with the University of Manitoba and in charge of alumni outreach.

10. Access to Justice: In April 2023 we welcomed Natasha Brown [LLB/2005] as Director of Access to Justice and Community Engagement. She will oversee the coordination of the Access to Justice Advisory Network which serves as a valuable resource for justice system stakeholders as well ass bring an access to justice lens to the Faculty of Law's clinical programs.

As esteemed members of our legal community, your voices and contributions are invaluable. We seek to foster a strong relationship between alumni and the law school as our goal is to be your lifelong partner in legal learning and support you throughout your professional journey.

We hope that you continue to feel at home here at Robson Hall and enjoy this publication. We are eager to hear from you and learn how we can better engage with you in your daily work. Together, let us build a stronger bond between our alumni and the Faculty of Law.

Faculty of Law celebrates exceptional alumni with new award series

o celebrate the achievements of graduates, the Faculty of Law created the **Faculty of Law Alumni Awards** to be presented annually. Nominees demonstrate standards of inspiring professionalism in one of three categories including Outstanding Alumni Award, Emerging Leader Award, and the Trailblazer Award. The inaugural Faculty of Law Alumni Awards were presented at the Practicing Professionals Reception held in April 2023.

#### 2022 OUTSTANDING ALUMNI AWARD—SHERRI WALSH [LLB/1985]

A litigator, adjudicator and arbitrator, Sherri Walsh is the Managing Partner of Winnipeg law firm Hill Sokalski Walsh. Much of her legal career has been spent serving the public interest and her work has had significant impact in the promotion of human rights and social justice in Manitoba with repercussions across Canada.

From 2011 to 2013, she acted as Commission Counsel to the Commission of Inquiry into the Circumstances Surrounding the Death of Phoenix Sinclair, which was the largest public inquiry ever held in Manitoba. The resulting report from that Inquiry made sixty-two recommendations to better protect children in Manitoba.

From 2009 to 2019, she served as an adjudicator under the Human Rights Code, serving as Chief Adjudicator from 2012 to 2019. Before serving as an adjudicator, she acted for the Human Rights Commission on complaints that resulted in positive systemic changes to Provincial legislation and policies.

Ms. Walsh was an arbitrator on The Manitoba Framework Agreement—Treaty Land Entitlement, signed in 1997, where she delivered decisions which resolved land disputes that had been outstanding for 150 years. Frequently acting *pro bono* as an intervenor for public interest groups, she has ensured that perspectives of groups such as the Manitoba League of Persons with Disabilities, the HIV AIDS Legal Network and the Assembly of Manitoba Chiefs, were put before the Court on matters including the unilateral imposition of DNR Orders, criminalization of HIV status, and the overrepresentation of First Nation children in the child welfare system.

Walsh has taught Civil Procedure at Robson Hall for nine years, and sits on many committees. Outside of legal practice, she volunteers for communitybased organizations including Harvest Manitoba and currently sits on the boards of the University of Winnipeg and the Manito Ahbee Festival.

Throughout her career, Walsh has achieved numerous firsts, including being the first woman in Manitoba to act as Commission Counsel to a large public inquiry, first person to perform the role of Chief Adjudicator under the Human Rights Code, first Integrity Commissioner for the City of Winnipeg, and first Municipal Codes of Conduct Appeals Director for the Province of Manitoba. She serves as a mentor to many young lawyers and is one of only a few women in the role of Managing Partner of their firm.

Described by her nominator as "honest, honourable and compassionate," Ms. Walsh shared the following words of wisdom for current law students:

- I am so honoured to be receiving this award and to be recognized by the professional school that launched my career.
- A legal education is a gift—one that will influence you forever and will give you a framework through which to navigate the world, in your personal and professional lives.
- You are moving into a future which is in many ways unknowable and uncertain but the education which you are working so hard to receive will give you the capacity to take action and influence outcomes—to pursue and achieve just results.
- As you look for the right career path, be true to yourself and follow what interests and inspires you.

- Find colleagues with whom you share sensibilities and perspectives.
- Think critically.
- Maintain a sense of curiosity and don't stop learning.
- Trust your instincts.
- Stay hopeful and be brave. Don't hesitate when faced with a challenge.
- Thing big but know that by taking even the smallest action you can make a difference.
- Engage with community and be compassionate in that engagement.
- Finally, remember to maintain your sense of humour.
- Don't take yourself too seriously and have a good time!
- I wish you all the best in your future endeavours.

#### 2022 EMERGING LEADER AWARD— DAYNA STEINFELD [BA(HONS)/2009, JD/2012]

Dayna Steinfeld is a lawyer at RavenLaw LLP. Called to the bar in both Manitoba and Ontario, she is committed to advancing the rights of working people, specializing in union-side labour law, employee-side employment law, long-term disability benefits, human rights and whistleblower protection.

Ms. Steinfeld has been recognized as a Lexpert Rising Star and a CBC Manitoba 40 Under 40. In 2019, she was awarded the Manitoba Bar Association Pro Bono Award for her work representing a coalition of poverty and mental health organizations on significant constitutional privacy issues before the Supreme Court of Canada.

Having started her legal career as an articling student at RavenLaw's Ottawa office, she clerked for the Honourable Justice Marshall Rothstein at the Supreme Court of Canada before returning to Winnipeg to work at a large firm in administrative, regulatory, labour and employment law.

• Look for mentors. Be a mentor.

Her nominator stated that Ms. Steinfeld demonstrates that commitment and hard work can help people achieve great things while promoting principles of access to justice and equality. Her willingness to help others achieve their goals is evident in the work she has done with the Manitoba Bar Association's Women Lawyer's Forum to advance the cause of equality for lawyers identifying as women working in the legal profession in Manitoba.

Dayna Steinfeld offered the following advice to current law students:

As a law student, lawyer or legal professional, never assume you are the expert because you are the person in the room with legal training. Be humble and curious. Take every opportunity to learn from, and be guided by, your clients and all those with whom you work and collaborate.

#### 2022 TRAILBLAZER AWARD— DR. JENNIFER SCHULZ [BA/1991, LLB/1994]

Dr. Jennifer Schulz is a Professor at the Faculty of Law, University of Manitoba and the current Associate Dean of the Juris Doctor program. While still a law student, Schulz had her first publication, publishing a chapter in Professors Barney Sneiderman and John Irvine's public health law text book.

After pursuing graduate studies at Cambridge and the University of Toronto, she started her career as a law professor at the University of Windsor, eventually returning to the University of Manitoba by way of the University of Toronto, Osgoode Hall and Harvard. She has been at Robson Hall since 2004, teaching and conducting research in the areas of Alternative Dispute Resolution, Mediation and Cultural Legal Studies. Dr. Schulz has served as both Associate Dean JD as well as Associate Dean of Research and Graduate Studies.

Dr. Schulz's teaching skills have been recognized multiple times: she was named Professor of the Year (2002) at the University of Windsor; Outstanding Teacher—twice (2015 and 2017) at the University of Manitoba's Students' Teacher Recognition Reception; and she received the Barney Sneiderman Teaching Award in 2019 from the University of Manitoba.

For her work in ADR, she was recognized with the Lionel J. McGowan Regional Award of Excellence in Dispute Resolution (2015) by the ADR Institute of Canada. Dr. Schulz frequently presents on the topic of ADR to the Manitoba Bar Association, the Canadian Bar Association, and at academic conferences across North America and Europe.

She has been instrumental in inspiring students to excel in their own careers. She serves as an inspiration to female law students, and is approachable and willing to advocate for the retention of women in the legal profession.

Dr. Schulz shares these words upon being acknowledged with the Trailblazer Award:

I am truly honoured to have received this award. It means a lot to me because it is from my alma mater and employer, the U of M, and specifically its wonderful law school, Robson Hall. My fellow professors and our students are what make Robson Hall a wonderful place to be every day. I especially hope our students know that not only can they find fulfilling careers as lawyers as a result of graduating from Robson Hall, but they can also find a myriad of other interesting and fun careers—like being a law prof—because they graduated from U of M.

## Alumni Spotlight

Meet the 2023 Distinguished Alumni Award for Community Service recipient

Learn about Howard Morry's journey from student to community builder and advocate

he University of Manitoba's Distinguished Alumni Awards recognize UM graduates across all faculties who have achieved outstanding accomplishments in their professional and personal lives, and who have been an inspiration to fellow alumni, current students and the community both near and far. The 2023 winner in the "Community Service" category was **Howard Morry [BComm(Hons)/81, LLB/1984].**  When Howard Morry decided he wanted to write for The Manitoban on his first day at UM, he walked right into the office, pitched an article and made it happen. His tenacity has not wavered much since then in either his legal career or dedication to his community. From an early age, Morry was introduced to community activism and encouraged to be deeply involved in youth organizations.

"Like many communities, the Jewish community has a tradition of volunteerism, leadership and philanthropy, and growing up I watched my maternal grandmother take that to heart," he says. "She didn't have much of her own, but she was still always out joining committees and volunteering for everything. She was a great role model for me, and as I grew up, I started getting involved at different levels and realizing where I could add value to different organizations."

Morry has volunteered extensively in the Jewish community, serving as the president of the Jewish Federation of Winnipeg, regional president, national board member and national New Leadership Chair of Canadian Friends of the Hebrew University and has held a variety of leadership roles among other Jewish community organizations. In the general community, he has served as President of a Rotary Club, the founding Chairman of the Canadian Association of Farm Advisors, Chair of the Lawyers Division of the United Way, to name a few.

"I had tons of energy and lots of vision and big networks, and I think because of that I became the youngest president, chairman, leader of several organizations. I was really working hard to try and make a difference," he says. "I learned a lot through trial and error and made some mistakes, but I always fell back on advice I received from my mentor, **Izzy Asper [LLB/1957, LLM/1964, LLD/1998]**. He liked to say 'Shoot for the stars. You're going to fail more often than you succeed, but when you fall, you're going to fall to the same place. So, you might as well shoot higher and then if you can achieve that, you know you're achieving more than you thought possible.'"

Throughout his career, Morry has also worked with many Indigenous organizations, including the Canadian Council for Aboriginal Business, and is highly regarded by First Nations, Inuit and Métis political and business leaders for his wisdom, sage advice and mentorship. Morry has proven exceptional in his openness and commitment to understanding and then representing the rights and views of Indigenous peoples in Canada, often challenging the status quo. He is a passionate advocate for economic Reconciliation, believing that this is essential to building a strong, healthy and inclusive Canada.

He was one of the founding members of the Arab-Jewish Dialogue, dedicated to encouraging positive relations and respect between Arabs and Jews in Canada and has worked with hundreds of supporters of peace in the Middle East to promote respect, dignity, tolerance and diversity.

For over two decades, Morry has been a part of the Friends of the Canadian Museum for Human Rights (CMHR) and led the Manitoba Capital Campaign initiatives. As a result, the Capital Campaign was a success and enabled the CMHR to be built without compromise, with over 75 per cent of the \$150 million Capital Campaign coming from Manitoban donors. Today, Morry continues to sit on the Board of the Friends.

Morry just received the Sol Kanee Distinguished Community Service Medal, a lifetime achievement award for dedicated leadership and service to the Jewish community. This year Morry will receive the University of Manitoba Distinguished Alumni Award for Community Service.

"I'm so appreciative of this award. It's especially meaningful to me because my son, **Josh Morry** [JD/2016], won the Distinguished Alumni Award for Outstanding Young Alumni a few years ago (2020). My wife, Hope, and I are so proud of both Josh and our daughter **Samantha** [JD/2021]," he says. "When I learned I won this award, Chancellor Mahon said to me 'like son, like father'. I told my son this. I said, 'I'm following in your footsteps'. For a dad, you know, that's everything. It is one of those wonderful moments when you do feel validated to continue doing the good work."

The Faculty of Law hosted its 2022 Homecoming event on September 21 in collaboration with Legal Aid Manitoba to celebrate the 50-year partnership that has existed between the two institutions. Since 1972, Legal Aid lawyers have supervised law students working at the University of Manitoba Community Law Centre (previously known as the Legal Aid clinic) to provide experiential learning opportunities to law students and ensure access to justice to persons who cannot afford a lawyer.

During the virtual event that was attended by alumni from as far away as Victoria, BC and

Melbourne, Australia, guests heard greetings from The Honourable Judge **Wanda Garreck [BA/1987, LLB/1990]** on behalf of the Manitoba Provincial Court; **Peter Kingsley, Q.C.[LLB/1994]**, Executive Director of Legal Aid Manitoba; Erin Wilcott, Executive Director of the Manitoba Law Foundation, and Dr. Richard Jochelson, Dean of Law. Associate Professor **David Ireland [LLB/2010; LLM/2014]**, Director of Clinics at the law school, acted as host, and moderated two panel discussions—one of supervising lawyers, and one of former students from the clinic's past, present and future.

During her greetings, Judge Garreck shared that she and her fellow members of the bench are always pleased to see student lawyers in their courtrooms. "Judges see students as enthusiastic, well-prepared and well-supervised," she said. Recalling her own days as a law student working at the clinic, she encouraged current students to take advantage of the opportunities the clinic offers to gain experience and make connections. "It's a good way to start your reputation," she said.

Professor David Deutscher, who acted as clinic supervisor from 1977 to 2015, explained that the clinic first got started as a result of movement by the law students wanting to both help people and get hands-on experience. "It was a period of experimentation," he said. His goal as supervisor was to ensure that student representation would not be perceived as "bargain basement" but rather that it would be the same if not better than paid representation.

#### Legal Aid lawyer Michael Walker [BA/1981,

**LLB/1985]** supervised the clinic from 2015 to current times, and saw students adapt to new technology and the expansion of services to include family law, prison law and Indigenous legal services. Walker was himself a clinic student who said "It's a community-building clinic."

The Honourable Judge **Rocky Pollack, Q.C.** [**BA/1969, LLB/1972**] was a student at the clinic in 1971—72. Upon first starting law school, he didn't recall having any sense of wanting to help "the little guy," but soon became inspired by his experiences at the clinic, working with fellow student Randy McNichol and the clinic's supervisor at the time, Al McGregor, who he described as "a hot-shot criminal lawyer" who ran a strict clinic. "It was an interesting time to be a law student," he recalled. Working at the clinic inspired him to want to be a "lawyer of change," he said.

Diane (Demeule) Hartley Holley [LLB/1995]

brought the unique perspective of having worked at the clinic as an administrative assistant from 1979 until 1986, during which time she helped guide many of the student volunteers. By 1990, she had enrolled in law school part time and became a volunteer at the clinic.

**Hayley Allardyce [JD/2019]**, now a junior associate at criminal defence firm Campbell Gunn Inness Seib, shed light on current clinical experiences,

recalling how "the clinic was a safe place to learn the practice of criminal law." She especially noted how law students had the luxury of time that practicing lawyers did not, and was thankful for the ability to call her supervising lawyer Mike Walker for help as needed. Further illustrating the supportive community surrounding the clinic and its activities, Allardyce shared that at her first trial, for which she had prepared for hours, she had forgotten to mention a critical issue in her conclusion, but the Crown graciously rose and prompted her in a supportive way.



At the end of the fall term, the University of Manitoba approved important course changes to the JD and LLM programs including:

- Mandatory Indigenous Course: Beginning in September 2023, all new JD students are required to take Indigenous Methodologies and Perspectives in 2L (this course is currently being taught as an elective).
- New Concentrations: JD students can choose to focus their studies in one of three new concentrations—Private Enterprise and the Law, Law and Society, or Criminal Law and Justice in addition to the existing concentration of Access to Justice in French. Concentrations are not "majors" but rather allow students in their final year of law to declare that they have concentrated their studies in a particular area as a way to distinguish themselves from other students.

LLM Clinical Opportunities: For the first time in the history of the Master of Laws program, LLM students will be able to select clinical course electives to enhance their experiential learning opportunities, starting in the fall term of 2023.

### Experiential Learning News

Faculty of Law continues to expand clinical options for experiential learning

n the fall of 2022, third-year law students had their pick of an expanded number of experiential learning, or clinical courses. Out of approximately 100 students coming into their final year of the University of Manitoba's *Juris Doctor* program, over half applied for an externship opportunity to get a chance to roll up their sleeves and do work helping clients with legal matters or seeing first-hand how law works in practice.

Six externships in addition to the new Rights Clinic and the continuing Public Interest Law Centre (PILC) clinic were available during the 2022—2023 school year. These included:

- Legal Help Centre
- University of Manitoba Community Law Centre (UMCLC)
- Manitoba Law Reform Commission
- L. Kerry Vickar Business Law Clinic
- Cochrane Saxberg Indigenous Community
  Clinic
- RobsonCrim Attorney General Externship

Clerkships with the Manitoba Court of Queen's Bench (now King's Bench) and the Manitoba Court of Appeal have been staples of hands-on for-credit opportunities available to third-year law students. Today, a total of 12 clerkship spots are available, each student earning six credit hours for the year. Professor Darcy MacPherson initially started the MBCA clerkship in 2004, and later added the Queen's (now King's) Bench in 2010 with students working on Criminal, Civil, and Family cases. Judges are involved in the selection process along with Faculty members.

The Legal Help Centre, UMCLC, the Manitoba Law Reform Commission and the Vickar Business Law Clinic are mainstays of the annual roster of externships. In 2022, the Faculty of Law celebrated a 50-year partnership with Legal Aid Manitoba in running the UMCLC, in addition to implementing a new expansion of services that have students helping with a wider range of files. Law students have assisted at the Legal Help Centre almost since its origins in 2011.

As with other clinics, the Cochrane Saxberg Indigenous Community Clinic will provide handson opportunities for students to interview clients, provide counsel, develop and manage client files, and conduct qualitative research. Students will especially have an opportunity to learn theory about decolonizing and Indigenizing law, and integrate these principles into the practice of law.

The RobsonCrim Attorney General externship placed law students with the Manitoba Department of Justice's Crown Law Analysis and Development department. Students worked directly with legal counsel and policy analysts at the branch to help with related legal research, cross-jurisdiction analysis and policy development.

With the growing number of clinics and engaged students, the Faculty had appointed Associate Professor **David Ireland [LLB/2010, LLM/2014]** as Director of Clinics. He worked with a team that included Assistant Professor **Brandon Trask [JD/2012]** (clinical professor), Senior Clinical Instructors **Elizabeth McCandless [LLB/2007, LLM/2020]** and Dr. Rebecca Jaremko Bromwich, along with staff members **Marc Kruse [JD/2015]** (at the time Indigenous Legal Studies Coordinator) and **Trina McFadyen [LLB/2020]** (Director of Professional Development).

Since Ireland was appointed a judge in the Manitoba Provincial Court in June, 2023, McCandless has assumed the role of Director of Clinics.

#### **JUSTIN PAULIC**



## LLM Program News

LLM Graduate Spotlight: Nalini Persaud

The Faculty of Law is very proud of its Master of Laws program which is designed to be completed in one year and is ideal for legal professionals to further explore and make contributions to research in their chosen areas of practice. This year we feature lawyer Nalini Persaud [BA/2005, LLB/2008, LLM/2022], who graduated from the LLM program in Oct., '22.



## What was your thesis on and who was your advisor?

Section 27 of the Canadian Charter of Rights and Freedoms requires that it be interpreted in a manner consistent with the preservation and enhancement of Canadians' multicultural heritage. My thesis, which is titled "The Charter's Multiverse: The Marvel of Section 27," systematically analyzes section 27's promise as a substantive Charter right and functional legal tool.

I could not have completed my thesis without the guidance of my advisor Dr. Gillian MacNeil. Her expertise and mentorship supported me through all stages of the LLM program.

#### Why did you choose that topic?

My decision to explore section 27 academically stems from a very personal interest in seeding ideas for developing the law in a direction that honours multiculturalism and combats racism and bias. My parents, Dushyanta and Angeli Persaud, came to Canada from Guyana and Trinidad to establish a better life for themselves and encountered many barriers in the process. As a woman and a child of BIPOC immigrants who grew up in Winnipeg, I have also been acutely aware that the way I experience the world personally is not from a position of power or privilege. In my professional life, I am often faced with examining the assumptions on which a law is based and considering the experiences of diverse groups. My thesis was an opportunity to do the same in the context of a fascinating provision that holds great promise for a more just Canada.

#### What advice would you give to anyone considering taking an LLM at Robson Hall, as to the benefits the degree will have to your legal career?

My lifelong commitment to learning is the motivating force behind my pursuit of a Master of Laws from the University of Manitoba. My LLM has afforded me an opportunity to further my legal education and apply my knowledge in my professional career as a public servant. More importantly, I have made a contribution to the legal research in an area I am passionate about, and which will hopefully be valuable in the face of growing diversity, and greater awareness of systemic discrimination, in Canada.

he University of Manitoba's Master of Human Rights (MHR) program was the first of its kind to be offered in Canada. Now having seen its third cohort of students graduate, the program is becoming established as a leader in offering practical and academic training for careers in human rights work. The program is a collaboration of the faculties of Arts, Education, Law and Social Work, and is housed at the Faculty of Law under the direction of Dr. Kjell Anderson, an Assistant Professor in the Faculty of Law. The program is supported by the Mauro Family Foundation which made possible the Mauro Chair in Human Rights and Social Justice, held by Dr. Nathan Derejko.

The MHR program offers both a thesis stream (16–24 months of full-time study) and a practicum stream (16 months full-time including a practicum of at least three months). The Master of Human Rights program's annual Practicum Symposium took place on Thursday, December 8, 2022 at the Canadian Museum for Human Rights. The symposium gives students enrolled in the interdisciplinary graduate degree's practicum stream an opportunity to present their major research papers and share experiences working at their respective placement sites.

Fourteen students presented in five different panel sessions which were divided into the topics of Human Rights and Mental Health, Human Rights and Education, Indigenous Rights, Perspectives on Human Rights, and Discrimination—Race, Gender, and Disability. "It was wonderful and enriching to all be together in the same room for the Master of Human Rights Symposium," said Dr. Kjell Anderson, Director of the MHR program. "The pandemic has been a bumpy ride, but our students have shown a lot of resilience and I know they were grateful for the opportunity to gather to share their experience and knowledge with each other and the community." Presenting student Piper Larson reflected on how removed from each other her cohort felt, due to the pandemic. This symposium marked the first chance some of her classmates were able to meet in-person. "It was an honour to listen to all of my classmates as they spoke of their practicum experiences and their upcoming research. The diversity in the field of human rights is remarkable and listening to what everyone is passionate about is truly special. I cannot wait to see where the MHR students go from here," she said.

Students in the practicum stream undertake work placements with leading local and international human rights organizations to gain practical, handson experience doing human rights work. 

## Donor News— A Brilliant Friend: The Legacy of Butch Nepon

Law professor's gift continues to help students after more than 20 years

Once upon a time there was a law professor who was beloved by students, colleagues and Faculty of Law alumni alike. His name was Matthew Bernard Nepon, and he was a graduate of the University of Manitoba's Faculty of Law, class of 1967. Everyone called him "Butch." He never had children, but for the past two decades, law students at his alma mater have continued to benefit from his legacy, whether they knew it or not. Now that family members who remember their 'Uncle Butch' are getting older, they thought it important to share the story of the extraordinary man behind the Butch Nepon Memorial Bursary. Currently valued at over \$1.8 million, the Bursary has supported a significant number of law students each year since it started disbursing support to students in 2006. To date, nearly \$900,000 has helped law students get through their studies. The story of Nepon's legacy at the Faculty of Law as both a former student and professor is one that should not be forgotten.

"Brilliant" was a word frequently used to describe Nepon by his professors, colleagues and students. In an interview in the *Manitoba Law Journal*'s special issue on *The Great Transition in Legal Education in Manitoba*(39:1), Professor Emeritus Cameron Harvey, who started teaching at the Faculty in 1966, remembered Nepon as a student in his Administrative Law class, which Nepon later taught himself, along with Constitutional Law. Harvey described his former student as "the most brilliant law student I have ever taught" (at page 114).

"He did not participate in class, but he would get to the exam, start writing, and write continuously for the whole exam," Harvey recalled. "The remarkable thing was: he would not only answer the question in terms of the law, he would answer the question in terms of sociology, or political science, or whatever other area may be involved in the answer. It would be a complete answer and it all just came flowing out of his head. He never thought about it, never made any notes. He never had to structure an answer. It was just a stunningly amazing performance." When they became colleagues on the Faculty, Harvey described Nepon as a creative thinker. "He would come into my office and run things by me and I would just marvel. It is like watching a hockey player or a soccer player doing something and you think, "How the hell did he do that?" He did not even want any feedback; he just wanted someone to bounce ideas off of."

Nepon loved teaching and the faculty so much that he wanted to continue supporting them after he was gone. He did so by donating a substantial gift to the University of Manitoba to create the **Butch Nepon Memorial Bursary**. This bursary has allowed students the financial support to pursue a degree in the Faculty of Law for more than 20 years, and will continue to do so for many more years to come.

UM is saddened to learn of the recent passing of Esther Halpern, Butch Nepon's sister. Gifts made in memory of Butch or Esther to the Butch Nepon Memorial Bursary will benefit students in the Faculty of Law in perpetuity. Jim credits the education he received at UM as the basis for all his career accomplishments and strongly believes in the potential of young minds to shape the future. "My grandfather and father were both graduates of UM and stayed very involved with the school. Due to family and personal ties, the University was always something I wanted to support. I wanted to find a way to have a connection with students while honoring my family name."

In the 20 years since the program was established, Jim and Sandra have connected with countless students whose lives have been impacted by their generosity. Many go on to make significant contributions to their profession and in the communities they serve.

"Being a Pitblado Scholar allowed me the freedom to focus on my studies, but more than that, gave me the motivation that allowed me to succeed. It set me up for success and opened opportunities for me," said 2004 and 2005 recipient, **Kathleen McCandless [LLB/06]**, who is now a Partner at Pitblado LLP.

UM alum David Sowemimo [BA(Adv)/2008, JD/2015], created a new entrance scholarship in 2021 with the intention of supporting Black students to pursue a career in law. It is the first scholarship of its kind at the University of Manitoba.

Decreasing the financial burden while starting a degree in law can relieve a great deal of stress and allow students to focus on their studies. The

first recipient, Keza Uwitonze, was awarded the Sowemimo Scholarship in 2021 and is now in her second year of the Juris Doctor program at the Faculty of Law. Thanks to the financial support of this scholarship, she is looking forward to a successful law career that will allow her to give back to the marginalized community.

"It's partially because of the scholarship that I didn't have to take out a student loan in my first year. With all the stressors of law school overwhelming me, I'm glad that there wasn't a financial burden weighing down on me as well," says Uwitonze.

The second student to receive the scholarship, Meseret Alem, started her first year with the Faculty of Law in 2022. At first, she was hesitant about applying to law school because she didn't have enough money, but she says receiving this scholarship and from a successful Black lawyer and the Robson Hall Bursary has made a massive impact for her as she begins her own law journey.

"I don't think there are enough Black specific scholarships at the University of Manitoba and that is something that I am hoping will change in the near future. I intend eventually to establish something at Robson Hall as well," says Alem.

"I'm delighted to see the impact that the scholarship is having on law students at the University of Manitoba. Keza and Meseret's respective journeys and experiences exemplify the reason for starting this scholarship in the first place. I can't wait to see where their legal careers take them," says Sowemimo.

The Faculty of Law joins the University of Manitoba community in remembering its extraordinary benefactor and alum, Marcel A. Desautels, CM, OOnt, OM. A former business leader and one of UM's, and the Faculty of Law's most distinguished benefactors and alumni, he passed away on January 31, 2023, at age 88.

Desautels [BA (LatPh)/55, LLB/59, LLM/65, LLD (Hon)/99] had generously supported the development of the Marcel A. Desautels Centre for Private Enterprise and the Law, which promoted the study and practice of integrating the two disciplines of business, law and the humanities as they apply to family-controlled and other private enterprises. By developing synergies between disciplines, the Centre's programs work to provide future lawyers and their clients with a better understanding of the opportunities and challenges facing privately held businesses. The Centre's areas of strength include Law & Technology, Business Organizations, Business Transactions & Obligations, Financing & Insolvency, and Alternative Dispute Resolution.

"The Faculty of Law owes an eternal debt of gratitude for the foresight of Marcel Desautels in addressing the need to educate law students in the inherently interdisciplinary nature of business law, and, in particular, in addressing the needs of familyowned businesses," said Dr. Richard Jochelson, Dean of the Faculty of Law at the University of Manitoba. "The law school shares these passions and The Desautels Centre for Private Enterprise and the Law has had a crucial impact on furthering business law research and education in Manitoba, and in advancing the study of and work by small businesses in this province."

Currently, the Desautels Centre consists of an Advisory Committee, a Research Cluster, a research journal titled the *Desautels Review of Private Enterprise and Law*, and it oversees the operations of the L. Kerry Vickar Business Law Clinic. The Centre also hosts an annual lecture featuring an exceptional scholar or business practitioner. Desautels' multi-million dollar gift was given to the Faculty of Law in 2007.

## Two UM Faculty of Law professors appointed to judiciary

wo University of Manitoba Faculty of Law professors were snapped up by the judiciary.On June 1, 2023, it was announced that Associate Professor Gerald Heckman would be replacing Justice W.W. Webb on the Federal Court of Appeal. Just over a week later, Manitoba's Minister of Justice and Attorney General of Manitoba, The Hon. Kelvin Goertzen [BA/92, B.Comm (Hons)/95, LLB/03], announced the appointment of Associate Professor David Ireland [LLB/2010, LLM/2014] to the Manitoba Provincial Court.

"While we are sorry to lose such excellent professors, the appointments of Professor Gerald

Heckman and Associate Professor David Ireland to the judiciary are a testament to the exceptional quality of expertise and legal acumen at Robson Hall," said Dr. Richard Jochelson, Dean of Law. "Their appointments reflect the depth of expertise and dedication to justice that our faculty possesses. It is a great loss for us, but Manitoba and Canada gain immensely from their talents. We are confident that Justice Heckman and Judge Ireland will serve with integrity, impartiality, and bring their wealth of knowledge and experience to their respective roles. We wish them every success in their new appointments and have no doubt that they will make significant contributions to the Canadian judicial system."

The former Professor—now Justice—Gerald Heckman taught administrative law, constitutional law, and language rights at Robson Hall since 2006. He also served as co-director of Robson Hall's Concentration in Access to Justice in French. Fluent in English and French, Justice Heckman holds a Bachelors of Applied Science (Génie Physique) from Laval University, a Master of Applied Science degree in electrical engineering from the University of Waterloo, a law degree from the University of Toronto, an LL.M. from Queen's University and a doctorate in law from York University's Osgoode Hall Law School. He has practiced labour, employment and human rights law and published extensively in the areas of administrative and constitutional law.

Justice Heckman served on the boards of several national organizations, including the Council of Canadian Administrative Tribunals and the Canadian Association of Law Teachers. He regularly participated as a faculty member in judicial education seminars on administrative law organized by the National Judicial Institute and Canadian Institute for the Administration of Justice. Justice Heckman served as a board member and president of the Association des juristes d'expression française du Manitoba, where he promoted initiatives to enhance access to justice in both official languages.

Throughout his teaching career, he has been presented with several awards including The Barney Sneiderman Award for Teaching Excellence (in 2022 and 2016), the Olive Beatrice Stanton Award for Excellence in Teaching (2016), and the Students' Teacher Recognition Award (CATL) (2010). This year he received the Faculty of Law's Extraordinary Service Faculty Award, for his diligence, professionalism, and leadership in providing support to his colleagues in service work on Access to Justice in French and in service work with Manitoba Justice.

As an Associate Professor at Robson Hall since 2016, Ireland was the Director of Clinics and taught Criminal Law and Procedure, Evidence, Advocacy, and Legal Profession and Professional Responsibility.

A graduate of Robson Hall, he was called to the Manitoba Bar in 2011 and practiced criminal law in both defence and prosecution work. Throughout his practicing career, he was involved in public interest legal work concerning inquests, public inquiries and human rights.

First appointed a professor at the University of Manitoba Faculty of Law in 2016, he was presented with the Students' Teacher Recognition Award (CATL) this April, 2023. In 2022, Ireland was very instrumental in expanding the University of Manitoba Community Law Centre to ensure more access to justice for Manitobans, and over the past year as Director of Clinics, worked to provide law students with more opportunities for hand-on experiential learning.

In addition to teaching, he led a full research program that centred on improving the delivery of criminal justice in Canada. His work interrogated the complexities of state/citizen interactions and aimed to lead positive policy change to improve equality and fairness in the criminal justice process.

The entire faculty, staff, student body and Robson Hall community at large, wish Justice Heckman and Judge Ireland all the best in their new appointments.

#### **DR. AKINWUMI OGUNRANTI**

Dr. Akinwumi Ogunranti (Akin) earned his LLB degree from the University of Ilorin, Nigeria, and was called to the Nigerian bar in 2013. He practiced law in a full-service commercial law firm for three years before starting his graduate studies. Akin earned his LLM and Ph.D. degrees in 2017 and 2022, respectively, at the Schulich School of Law, Dalhousie University. His Ph.D. thesis is titled *Africa's Contribution to the Development of the Norm of Corporate Responsibility to Respect Human Rights.* His research interests include business and human rights, private international law, investment law, and dispute resolution relating to corporate accountability and access to justice.

Akin has published nationally and internationally. His recent paper, *Localizing the UNGPs: An Afrocentric Approach to Interpreting Pillar II*, is published in the Business and Human Rights Journal. His forthcoming paper on international investment law titled *Why the Multilateral Investment Court is a Bad Idea for Africa* is forthcoming in the Dalhousie Law Journal. Akin is licensed to practice law in Nigeria and Nova Scotia, Canada. He is a member of the Nigerian Bar, the Nova Scotia Bar Society, the Chartered Institute of Arbitrators, and the Association of Certified Antimoney Laundering Specialists.

Yvan holds a Juris Doctor degree from the Peter A. Allard School of Law (UBC) with a Business Law Concentration and a Specialization in Aboriginal Law, as well as a Master of Laws from Osgoode Hall Law School with a Specialization in Business Law. He is called to the Bar in the Province of British Columbia and Manitoba.

Prior to joining Robson Hall as an Instructor, Yvan regularly guest lectured on the subjects Indigenous economic development and governance at the University of British Columbia and University of Victoria, and taught Commercial Law and Corporations I as a Practicing Professional Instructor.


